

\$20,000 Mistake: The Perils of Choosing Pirate Parts Over NETZSCH Original Equipment

A Case Study on the Importance of NETZSCH Original Spare Parts

When "Or-Equal" Became a \$20,000 Paperweight

During a routine sales visit to a Northeast wastewater treatment plant (WWTP), a NETZSCH distributor, Wood Equipment, was alerted to declining performance in their NETZSCH 4NESP100 pump, installed in 1988. Upon inspection during a scheduled shutdown, the rotor was found to be significantly worn. Wood Equipment promptly provided a quote for a replacement NETZSCH rotor.

However, complications arose when the part appeared on the WWTP headquarters' ERP/bid portal with the phrase "or-equal proposals accepted." Despite Wood Equipment's warnings about the risks of using a non-NETZSCH or "pirate" part, the purchase order was awarded to a counterfeit part provider.

The Fallout: A \$20,000 Incompatibility

Weeks later, the WWTP lead operator

reported that the counterfeit rotor was incompatible with the pump, rendering it a \$20,000 paperweight. The pirate part provider refused to take the part back, and the WWTP purchasing department was unresponsive. Operations were left with a non-functional pump and a significant financial loss.

The Hidden Dangers of Pirate Parts

Counterfeit parts, often manufactured with substandard materials and lacking rigorous testing, can lead to:

- Incompatibility with existing equipment: Counterfeit parts may not fit or function as intended, leading to operational disruptions.
- Increased wear on other components: Inferior materials can accelerate wear on adjacent parts, leading to more frequent replacements and higher maintenance costs.
- Safety hazards: Substandard components can compromise safety, leading to potential hazards in the workplace.
- Loss of warranties: Using

non-original parts can void manufacturer and distributor warranties, leaving operators responsible for all repair costs.
